

OrthoCarolina Spine Surgery Fellowship Experience

- Two fellows per year
- Cases 1,800-2,000/yearly available
- Fellows participate in ~500 cases, primary surgeon or first assistant
- Cases: 60% degenerative, 20% deformity, 10% trauma, 5% tumor, 5% pediatric
- All areas of spine-cervical, thoracic, lumbar-represented
- Fellows have own clinics, participate in residency spine clinic





OrthoCarolina Spine Surgery Fellowship Responsibilities

- Neuropedics Call
 - 1st 6 months
 - Precepting 1 day/month service dependent
 - 2nd 6 months
 - Independent paid call, backed up by attending; service dependent
- Weekend Rounding
 - Alternating weekend
 - including holidays
 - Except when at fellowship sponsored meetings
- Weekday Rounding
 - Round on the patients you operate on
